Project name: Carpet and Tile replacement.

Project location: Project#1: Bath Elementary School (BES) Project#2: Chocowinity Primary School (CPS) Project#3: John Small Elementary School (JSS) Project#4: Southside High School (SHS)

Project: This project covers 4 schools in the district. This project consists of the removal and replacement of old carpet with new and the removal and replacement of old carpet to VCT tile.

BES has approximately 890 SQFT of carpet that is to be removed and replaced with new carpet and 900 SQFT of carpet that is to be removed and replaced with VCT tile.

CPS has approximately 3100 SQFT of carpet that is to be removed and replaced with carpet and 12000 SQFT of carpet that is to be removed and replaced with VCT tile.

JSS has approximately 6200 SQFT of carpet that is to be removed and replaced with carpet and 1600 SQFT of carpet that is to be removed and replaced with VCT tile.

SHS has approximately 2000 SQFT of carpet that is to be removed and replaced with carpet and 1900 SQFT of carpet that is to be removed and replaced with VCT tile.

All measurements are approximate. BCS is requiring all new carpet be carpet tiles, color to be determined for the tile and carpet. Bid should include new cove base for entire project.

Contractor expectations: Contractor is expected remove all furniture as needed to complete this project and to keep a safe and clean working environment at all times being mindful for the potential that employees and students may be near the work area at any time. Contractor is responsible for all field measurements needed to complete this job successfully. At completion of the job contractor is expected to clean and remove all unused material from the work area. Contractor is required to provide itemized list of materials needed for this job with the bid sheet.

Contractor must provide Beaufort County Schools with a list of all personnel that will be on the project and assure that all personnel have had a sex offender background check. Contractor is to make sure that all staff are aware that Beaufort County Schools is a tobacco free site.

The successful contractor will be responsible for all work detailed in this Request for Proposal (RFP) or subsequent amendments. Beaufort County Schools reserves the right to select a firm which it deems to offer the best overall package, including information regarding the contractor's ability to meet the required schedule. Past performance on other similar projects will be a consideration in the selection of the chosen contractor. Beaufort County Schools reserves the right to reject any and all bids.
